### **SHERIFF'S DEED ON ORDER OF SALE**

#### ***KNOWN ALL MEN BY THESE PRESENTS, THAT;***

And Whereas, the said Court at its **Term of Sale** Term, **Term Year**, having examined the proceedings of the said Sheriff aforesaid, and being satisfied that the sale aforesaid had been made in all respects pursuant to said judgment and order of sale, and in accordance with the provisions and requisitions of the statute regulating such sales, did order that such sale be confirmed, and that the said Sheriff should convey the said real estate by deed in fee simple, to the assignee, **Assigned**, and that the deed was delivered to the Sheriff, who is appointed as agent of **Assigned** for the sole purpose of accepting delivery of the deed.
